Mrs. Tucker updated the board on the progress of building maintenance projects

Cokel welding will be fixing the post on the awning out front. The cost will be \$400 for two poles and the labor will be \$80 an hour. He thought it would take an hour or so to fix. The board would like to have the bill sent directly to Matt Miller.

The dumpster for trash has been delivered and is getting filled up with items we have decided that need thrown away. We are still waiting for the metal recycling dumpster to be delivered. Once that is delivered we will get all of the stuff on the side of the bus barn recycled.

The restroom project is mostly complete. The plumber will be back to put plastic covers over pipes. John still needs to install feminine napkin trash receptacles.

A list of the next projects to be completed based on our Health Life Safety inspection include:

- 1. Replacing doors from Cafeteria to maintenance room and maintenance room to kitchen-these need to be fire suppression doors
- 2. Replacing cafeteria doors-2 sets towards the Pre-K playground
- 3. Fire Suppression hood replacement/upgrade in kitchen
- 4. Replace food steam table wells in cafeteria serving line

- 5. Concrete slabs on exterior doors surrounding gym toward baseball diamond and weight room
- 6. Driveway-resurfacing/starting over of the asphalt- not health life safety.

*For next school year, locker room restrooms upgrade to meet ADA compliance

The board established the committee to meet with the teachers to start the process of the Intent to Bargain with the DCEA. The members on the committee will be Castillo, Faul, Schaefer, and Wibbell.

Mrs. Tucker is recommending 1.5 million to invest in a certificate of deposit There will be 7 CD's 2 at \$500,000 and 5 at \$100,000. Stronghurst has 4% with nine months to mature. Becky Thompson will call other banks and see if the can get a better deal.
